The Transient Boater named in this agreement shall carry a minimum of \$300,000.00 liability insurance on the boat named in this agreement, and provide confirmation of current status of such coverage to the Harbor Master.

Checkout time is no later than midnight on the day of departure.

Boaters must ensure their vessel is tied appropriately and securely in the slip or alongside the pier to which they are assigned.

Boaters are reminded to be considerate of other boaters and to maintain an attitude of cooperation and agreement throughout their stay.

Bay-Waveland Yacht Club assumes no liability for boaters, their vessels, or their guests while the boat is docked in the Bay-Waveland Yacht Club Harbor.
